At the conclusion of his career, Hilbrich was the Area Managing Partner for all offices of KPMG in Florida and Puerto Rico and was a member of the National Board of Directors of KPMG as well as Chairman of the KPMG Foundation.

Hilbrich has made volunteerism and community service a primary focus. He presently serves on the board of the Bishop Moore High School Endowment and Charitable Trust and is a member of the Dean's Advisory Council of the School of Business Administration of the University of Central Florida and the Dean's Advisory Council for the Kelley School of Business at Indiana University, his alma mater. Hilbrich has exceptional experience in the governance of nonprofit organizations, having served as Chairman for numerous philanthropic organizations including the Community Foundation of Central Florida, Florida Symphony Orchestra, Heart of Florida United Way, Junior Achievement of Central Florida and the University of Central Florida Foundation.
